

Modest Means Incubator Program for Creative Arts & Innovation Lawyers

Regular Referral Clients

Regular referral clients apply to CLA to be matched with an attorney. These clients receive a free 30-minute consultation then negotiate with the attorney for additional fees beyond the initial consultation.

Pro Bono Clients

Pro Bono clients apply by completing an initial intake and a detailed financial screening. CLA takes a holistic approach reviewing many factors, including the applicant's adjusted gross income, not to exceed 150% of the current federal poverty quidelines.

Modest Means Clients

If an applicant does not qualify for pro bono assistance, they may qualify for one of three tiers within our modest means program. These tiers offer low fixed legal fees of \$60, \$80 or \$100 per hour.

California Inventors Assistance Program Clients

The CIAP applicant's financial screening includes a review of adjusted gross income not to exceed 300% of the current federal poverty guidelines. A detailed inventor's questionnaire is also required.

Program Description

California Lawyers for the Arts (CLA) Modest Means Incubator Program (MMIP) is uniquely focused on helping young lawyers develop their own private practice in Entertainment, Arts and Innovation law. A major component of the program is personal mentorship with 30+ entertainment and arts law practitioners available to help participants as they develop their law practice.

Each MMIP participant is provided with a desk, HD phone, high-speed internet access, high-capacity printer, full access to CEB online research materials, Lexis/Nexis, PLI educational programming (with MCLE credit), law office management software, and many other law office amenities. Each MMIP participant's name is listed on the building directory and on a name-plate on the suite's door.

Each MMIP participant is enrolled CLA's State Bar Certified Lawyer Referral & Information Service (LRIS) and receives referral clients through the service to help them build their practice. CLA's LRIS has served California's creative arts and innovation community since 1974. CLA's LRIS also administers the California Inventors Assistance program, the largest regional patent pro bono program under Section 32 of the America Invents Act.
